(LIMITED TO THE FIRST 3500)

This promotion (“**Promotion**”) is organised and run by Huawei Technologies Africa (Pty) Ltd (“**Huawei**”), including its affiliates, partners, associates and agents together only with **Vodacom**, being 1 (one) of the authorized cellular operator within South Africa (the “**Organiser**”). The Promotion is open for entry by all South African residents of 18 years and older with a valid South African identity document, except employees of the Organiser and its advertising and/or promotion agencies, outlet owners, retailers and wholesalers that form part of the Promotion and their immediate families.
